Some resources from the USDA Forest Service Northern Research Station

The Northern Research Station has a new publication called Rooted in Research. This bimonthly publication focuses on the management implications of the latest research for natural resource managers. This short (2 to 3 pages) pdf-format publication features synthesized scientific information for high-priority land management needs, delivering key science findings to people who make and influence decisions about managing land and natural resources.

This recent edition (<https://www.nrs.fs.fed.us/rooted/4>) - Saving Eastern Oak Forests: Prescribed Fire Impact on Timber Quality – addresses an emerging topic as fire is reintroduced to oak forests. As an enticement for the full synthesis document (only 3 pages), here is the abstract - Oak-dominated ecosystems in the eastern United States rely on periodic fire to create conditions that are conducive to oak regeneration. However, concern about reducing timber quality has made some managers wary of using fire as a management tool. A team of Northern Research Station scientists, foresters, and ecologists are collaborating to assess timber quality by inventorying trees across multiple national forests that have varied prescribed fire histories. Their findings indicate that economic damage to overstory timber value from prescribed fire is usually minimal, particularly compared to the costs of regenerating oak by other methods such as tree planting. This research is helping land managers and forest owners differentiate between uncontrolled wildfires and beneficial, low-intensity fires, and to calculate the economic advantages and disadvantages of prescribed burns in different forest stands.

Mike Huneke called the meeting to order at 6:33.

- 1. Previous Minutes were approved and published in Allegheny News**
- 2. Treasurer's Report / 2020 Budget – Steve Resh**
 - a. In 2020, spent about \$21K, income of \$19,900
 - b. Balances as of Dec 31, 2020: Checking \$11,906; Franklin Income fund \$69,897; Student fund \$935
 - i. Motion for 2020 budget made by Cecile, seconded by Bud, and approved
 - c. 2021 Budget – expected income from dues and donations- \$15k and expected expenses including Director stipend, HSD assessment, travel and misc- \$15k;
 - i. Motion made, seconded and approved
 - d. Kimberly will ask National about setting up separate account for Convention \$\$
 - e. Tim Slavin will audit the books again for 2020
- 3. Chapter Dues**
 - a. Cecile presented protocols for submitting information to Nationals for dropping dues to PA Executive Committee; will be mentioned at March 10 annual business meeting.
- 4. Executive Director's Report – Susan Lacy**
 - a. Many chapters still owe tax information to Susan. She will file for an extension.
 - b. Susan is meeting with Lori and other executives in similar positions to her on a regular basis to discuss administrative issues.
- 5. Membership Committee Report – Cecile Stelter**
 - a. 610 members; 7 out of 10 chapters decreased; lost about 85 total in last year
 - b. Nationally are just below 9456 members; in 2019 was 10,813
 - c. Jonathan mentioned a workshop / training to recruit and retain young members; Mike suggested a subcommittee on recruitment
- 6. Program Committee Report – Dave Trimpey**
 - a. Excel spreadsheet put together to project out who is hosting ANSAF meetings; Winter 2023 needs to be resolved (could be PA division, or NJ should be asked if they would like to make up from missing Winter 2021);
 - b. After resolution of Winter 2023 host, list could be posted on ANSAF website

10. PA Chair and Member at Large Vacancies

- a. Kimberly will serve as Interim Chair for 2021; a nominee for Chair elect has been identified; and Kimberly will contact 2 potential nominees for chair
- b. The Slate will be provided at the March 10 business meeting
- c. A potential member at large hasn't been identified yet

11. District 7 Report – Sarah Wurzbacher

- a. **Young Professional on Board:** The YP is a non-voting member of the board with a one-year appointment. There has been only one thus far, but the Board is soliciting nominations for the next rep:
https://www.eforester.org/Main/Community/National_Elections.aspx, A candidate for the district is selected from among the pool of nominees by the District 7 Board Representative (Sarah Wurzbacher); a single national candidate is ultimately selected/finalized from that pool by the President (Gene Kodama). Reach out to Sarah Wurzbacher (sjw246@psu.edu) for more information, to nominate an applicant, or self-nominate and apply. Criteria for YP board member (materials due June 1, 2021 for service in 2022):
 - i. Under the age of 40 (at the time of board appointment)
 - ii. An SAF member in good standing
 - iii. A college graduate
- b. **New SAF Awards Program Platform Launched January 15:** Nominations for 2021 Awards opens January 15 closes March 15.
 - i. New award opportunity: 2021 Gregory Award.
- c. **SAF National Convention:** Abstract submissions are being accepted for individual presentations, panel presentations, organized sessions, pre-conference workshops, professional development seminars, science flashes, and posters for the November 3-7 national convention in Sacramento. SAF 2021 will explore “Forests for All” and highlight the ecosystem services provided by forests. March 31 is the

deadline for presentations, seminars, panels, and workshops; science flashes and posters are due August 31.

- d. **Foresters' Fund Grants:** \$80,000 in Foresters' Fund grants have been approved by the SAF Board
 - i. \$40,000 available for regular and special grants
 - ii. \$40,000 for Leadership Development grants
 - iii. February 15 is the first deadline of the year for regular grants up to \$1,500
 - iv. Proposals for Special grants up to \$5,000
 - v. Leadership Development grants up to \$15,000 are accepted one time per year and are due June 15.

- e. **2021-2023 SAF Strategic Plan:** currently under development; once approved by the Board, there will be a strategy to share the plan with the broader membership.

- f. **National SAF Position Statements (in response to an ANSAF member question):** National Position statements are relatively generalized statements, as they are to cover broad topics. The CFP (Committee on Forest Policy) works together to create the scope, purpose, and editing of the statement together with a lead author, who is responsible for seeing the position statement all the way through the process. After a position statement is approved by the Board, it goes out through the e-Forester, Forestry Source, and is updated on the SAF website. Each position statement has a 5-year life and is reviewed and updated typically the last year before it expires. When a position statement is ready to be reviewed for an update, the old statement goes out to HSD and an appropriate working group by the Chair of CFP to request feedback on the topic. State Societies can use position statements as they see fit and are always welcome to reach out for assistance on a local issue or with questions in regards to the position statements. A forthcoming orientation package includes information for state society policy chairs on how to craft their own position statements and resources on how to utilize national position statements. Members who are particularly interested in this process should reach out to Danielle Watson or join CFP, which needs diverse representation to help craft those position statements.

- g. **Recent Policy Work**
 - i. SAF recently sent a memo to the Biden transition team highlighting the importance of forestry and forestry professional to meeting priorities of the Biden Administration.
 - ii. SAF and over 100 partners, including many from the [Sustainable Urban Forests Coalition](#), recently shared a set of recommendations with the Biden Administration about fostering thriving and equitable communities through healthy urban and community forests.
 - iii. SAF joined over 60 partner organization to oppose revising the NRCS conservation program manual with the new definition of nonindustrial private forest land (NIPF) proposed in the Federal Register on December 17, 2020. As proposed, the new definition would be significant departure

- from the long-standing definition and would exclude landowners who are eligible for other NRCS programs based on acreage owned.
- iv. The full SAF membership and external individuals were invited to participate in the Educational Policy Review Committee (EPRC) survey to gather public comment on the proposed revisions to the accreditation standards via an article in the e-Forester.
 - v. As national bills related to trillion tree initiatives are introduced, SAF will engage with partners to help make sure language includes holistic forest management and not just planting trees. Related to the international trillion tree effort: the secretariat for the U.S. is American Forests. Terry has been in contact with their president and CEO, and SAF will be pledging to officially be a part of the effort in late 1st quarter/early 2nd quarter of 2021.

12. National Convention – Kimberly Bohn

- a. Date: September 18-23, 2021
- b. Kimberly will be seeking/recruiting volunteers to serve on Convention Committee in March. Most important to start ASAP in 2021 is the Technical Tour coordinator and subcommittee and Local sponsorship/fundraising coordinator. Other Committee leads include Local Publicity, Student Coordinator, Volunteer Coordinator, Foresters Fund/silent auction coordinator. Their responsibilities would step up in very late 2021.
- c. Nan Pond serves as Program Chair- early discussions of a theme to revolve around the mosaic of land uses, forestry practices, and relationships to forests across the rural, suburban, urban gradient (picture the diversity of land and people across the Chesapeake Bay watershed)

13. Chapter/Division Reports – including any changes to officers

- a. PA- worked with other PA forestry associations to create a calendar show casing forestry in PA; these will be distributed to students at various colleges across PA;
 - i. Foresters Fund Writing workshop was successful- about 20 participants
- b. NJ annual business meeting March 19
- c. MD summer meeting Aug 25-27, virtual meeting this spring on pest management, Foresters Fund activity postponed to next January due to COVID
- d. WV had virtual meeting in February on markets- 92 people attended. Jeff Kochenderfer is new chair (attended Leadership Academy in 2018). Possibly do another zoom meeting in summer.

 - i. Bylaws must be approved by general membership, which will be presented at March 10 meeting;
 - ii. Then must discuss process for selecting a student
