District VII Council Report

The main task at Council's March meeting was to interview and evaluate three candidates for the Executive Vice-President position. Council identified two "finalists," both of whom would be fine EVPs in our judgment, but as of this writing we have not yet completed a hire. Very soon, I hope.

Council approved a new mission statement recommended by the Membership and Credentialing Task Force:

The mission of the Society of American Foresters is to advance the sustainable management of forest resources through science, education, and technology; to enhance the competency of its members; to establish professional excellence; and to use our knowledge, skills, and conservation ethic to ensure the health, integrity, and use of forests to benefit society in perpetuity.

This statement will be folded into our new Articles of Incorporation (needed to register the organization under the new DC law) and submitted to the general membership for a referendum vote in the fall. The task force is considering other recommendations, including possibly changing our name ("SAF" has been suggested). Its final report is expected in June.

The other major item of business was a discussion of draft revisions to our Bylaws (currently known as the Constitution) – revisions that are needed to comply with the new District of Columbia law and, in general, bring this document up-to-date with a little "spring cleaning." The document is now back in committee for more work and will be brought to Council for a vote in June. I'll inform you after the June meeting of any significant changes to current practice, and the complete document will be on the ballot in the fall for a membership vote.

Minutes of the Executive Committee Meeting Allegheny Society of American Foresters Williamsport, PA February 19, 2014

The meeting of the Allegheny SAF Executive Committee was called to order by Rachel Reyna, outgoing Chair, at 3:05 pm. Introductions of those members present were made and included:

Susan Lacy, Executive Director; Jack Perdue, Web Master; Kip Powers, Executive Committee Member; Steven Kallesser, NJ Division; Cecile Stelter, Plateau Chapter; Roy Siefert, Executive Committee; Dave Trimpy, Plateau Chapter Chair; Todd Hagenbuch, Pinchot Chapter Chair; Bob Merrill, PA Division Chair; Richard Lewis, Executive Committee Member; Steve Koehn, Chair Elect Allegheny; Robert Schweitzer, Western Gateway Chair; Kim Steiner, SAF Council Rep; Rachel Reyna, Outgoing Chair Allegheny; Michael Kusko, Incoming Chair Allegheny; Jonathan Kays, Awards Chair Allegheny; Steve Resh, Treasurer Allegheny.



The gavel was passed from Rachel to Mike Kusko who chaired the remainder of the meeting. Mike asked that the minutes of the Summer Meeting 2013 which was held as Mont Alto, be approved. Resh moved, Rayna seconded, and the minutes were accepted unanimously.

Resh presented the Treasurers report for the 2013 calendar year (Complete report is presented elsewhere.). Income for the year were listed as \$16,588.50 and expenses for the year were listed as \$17,469.55 which results in a balance in the checking account of \$12,004.62. Resh also reported that the Educational

Endowment Fund CDs which provided interest for educational grants were closed in November of 2013. As these CDs renewed, the interest rates were being quoted as low as 0.4%. The Executive Committee felt that these low interest rates were keeping the fund from being effective and decided to invest the funds in a mutual fund account. The entire \$52,586.35 was invested in a Franklin "A" Fund in the hopes of increasing our earnings to approximately 4%. While this fund is considered conservative, there is still a risk of taking a loss.

A Student Savings Account containing \$1,061.22 was established from funds which were donated from a successful Summer meeting held on the Mont Alto campus. These funds will be used to support students in the Allegheny Society.

Discussion of the 2014 budget was next. Various ideas to raise income were advanced and included increasing advertisements in the *Allegheny News*, applying for grants, seeking more donations, and examining savings made possible by limiting the mailing of copies of the *Allegheny News* to members who do not have computer access or have inadequate computer access for them to use the electronic format. All of these will be considered. A motion was made by Richard Lewis and seconded by Steve Koehn to accept the Treasurer's report and to limit expenditures in 2014 to \$16, 500. The motion passed.

Kim Steiner reported as our SAF Council representative. The major business currently before Council is the hiring of the new Executive VP. Kim believes there are several quality candidates who have applied for the position and will be interviewed. Dr. Steiner urged all members to attend the National Convention which will be held in Salt Lake City in October. This convention will present a rare opportunity to meet with the Canadian Institute of Forestry as well as the IUFRO World Congress members. Finally, Kim reviewed some changes to the SAF constitution which will be voted on this year. These changes are made necessary because of the reincorporation of our organization. The leadership of SAF is seeking a change which would allow Council to approve some changes to the constitution without a vote of the full membership.

Rachel Reyna gave a report of what occurred at the HSD meeting. Rachel spoke of the availability of national staff to help incorporate social media into the Division and Chapter levels. She also spoke of the opportunity to use event coordinators to plan meetings of the SAF. These coordinators might help reduce the cost of SAF events. Rachel's complete report can be found in the winter edition of the Allegheny News.

Susan Lacy, Executive Director, requested that all Divisions and Chapters of the Allegheny SAF submit Treasurer's Reports as soon as possible. These reports are necessary for her to complete the Allegheny federal tax returns. Susan asked the Executive Committee about the possibility of acquiring the necessary infrastructure so that credit cards could be accepted as payment for meetings and merchandise. This idea was tabled because of the revolving nature of how our meetings are hosted. Susan also discussed the idea of establishing a scholarship or other memorial to honor Lloyd Casey who recently passed. Richard Lewis and Susan will explore this possibility.

Jack Perdue, webmaster, reported that he has scanned many of the oldest editions of the Allegheny News and they are available on our web site. He is considering moving the web site to a different host where content would be easily browsed on any device. Finally, Jack will post any information on the web site that pertains to Chapter and Division operations. Please just let Jack know what you would like to see posted.

Jonathan Kays reported as Awards Chairman. Both the Forester of the Year Award and the Bauer Outstanding Service to Forestry Award will be presented at the banquet this year. Jonathan urged all members to consider the nomination of a deserving colleague for these awards. Jonathan noted that an individual may not receive both awards in the same year, and that any member can nominate another member.

Ned Karger distributed a list showing previous winter and summer meeting hosts as well as the expected future hosts. Please let Ned know if the future schedule presents any difficulties. He asked that our winter meeting dates be coordinated with the Tree Farm meeting dates so that members may attend both of these meetings. Ned also reminded future hosts of the summer meeting that if this meeting is scheduled prior to August 1 that New Jersey members find it very difficult to attend.

Rachel Reyna announced that a memorial song titled *Farewell to a Forester*, written by Steve Resh will be sung at the banquet held during this winter meeting. This song was written in tribute to members who have died in the past year.

A motion was made by Resh, seconded by Reyna, which would prohibit making any grant from the Educational Endowment Fund which would reduce the balance in that account to below \$50,000. The motion was tabled pending further information.

A motion was made by Steve Kallesser, seconded by Steve Resh, asking the Allegheny to support two Forester Fund grants which the New Jersey Division will make to the national office. The motion passed.

Division and Chapters made reports concerning activities being conducted by them. There was a tremendous variety of events being conducted throughout the Allegheny in support of good forestry.

Mike Kusko adjourned the meeting at 6:15 pm.



Two Forestry Awards Presented at Allegheny SAF Winter Meeting

Howard G. Wurzbacher, Jr. was the recipient of the Robert W. Bauer Outstanding Service to Forestry Award for 2013 and he was presented with a plaque at the Winter Meeting banquet on February 20. The purpose of this award is to give official recognition to professional achievements in forestry, and to recognize superior service to the Society of American Foresters.

Howard is a Regional Forester with the Pennsylvania Game Commission for the Northwest Region and has accumulated a number of professional accomplishments in the field of forestry over the last 34 years. The early part of his career included employment in procurement forestry with private companies, which led to forester and regional forester positions with the Pennsylvania Game Commission, starting in 1993. Howard is a SAF Certified Forester.



Howard also has a long record of service to SAF, which is a key criteria for the award. He has served with the Plateau Chapter since 1994 as Chair and associated positions, and served on the Allegheny SAF Executive Committee from 2002 to 2010 as awards chair and in other capacities. He has served on planning committees for a number of SAF meetings over the years, including the 2011 Allegheny Winter meeting hosted by his chapter. Students have benefited from his many years of service as the organizer of "Walk in the Forest" program for fourth

graders in a local school district. In addition to his professional work, Howard is active in local and regional community associations.

Howard's comments at the awards presentation clarified his recognition of Robert "Bob" Bauer as his role model during his career, and it is because of Bob Bauer's example that the award is so named. Howard also recognized his mother and the important role she has played in his life and professional success. Howard is pictured above with his sister, his mother and his wife, Cindy.

Robert Remillard, was the recipient of the Forester of the Year Award and he was presented with a plaque at the Winter Allegheny SAF meeting by Rachel Reyna and Jonathan Kays, Awards Chair. The purpose of the award is to give official recognition to current professional achievements in forestry, to recognize a specific accomplishment or achievement in forestry during the previous year and to demonstrate to the public that the profession is a vital and active part of the total conservation effort.



Robert has been a forester for over 35 years and has worked in a variety of positions with the USDA Forest Service and the USDA Natural Resources Conservation Service. He is an SAF Certified Forester. Bob is recognized for his recent work that has reinvigorated the Pinchot Chapter over the last few years. It started when he attended a Chapter meeting and offered to take over the Treasurer position. After that he used his organizational skills and enthusiasm to put together quality meetings and workshops for the Chapter, which resulted in a dramatic jump in meeting attendance. Todd Hagenbuch, the current Chair of the Plateau Chapter, acknowledged it was Bob's input and assistance that were the major force for the change in the Chapter. Bob is a great example of a professional forester who is giving back to help the profession.

Allegheny SAF at the Playboy Club - 1974

Jack Perdue mentioned in his remarks at the SAF winter meeting in Williamsport that the Allegheny SAF (ANSAF) had once met at a Playboy club. His comment brought pleasant memories to me as that event happened on February 6 - 8, 1974 at the Playboy Club in MacAfee, New Jersey. A number of significant events happened during that annual meeting. The bylaws were changed and all officers were sworn in for two year terms beginning in 1974. I was sworn in as ANSAF Secretary/Treasurer for a two year term.

Some of our members were skeptical about meeting at a Playboy club for fear that it would hurt the image of the SAF. Eventually these fears were allayed and the meeting place was approved. It is interesting to note that one ardent detractor soon changed his mind about "hurting our image" as a Playboy bunny served him his cocktail.

Two major impediments to the meeting were a snow storm and the first gas shortage the U.S. ever experienced. Waiting in line for gas was a common sight in 1974. The gas shortage made car-pooling more amenable to attendees. I still recall a van with six foresters in it heading back to West Virginia in the snow.

During the business meeting, Ben Stout made a resolution to establish the Reginald D. Forbes Art Competition to create and foster the arts among members of the ANSAF and their families; to commemorate the pioneering efforts of Mr. Forbes; and to arouse the artistic talents and interests of foresters. Charlie Newlon always recites this fact at the ANSAF Winter meeting before he hands out the awards for the Forbes art competition.

George Pierson was program chair and had a logger, for the first time that I can recall, speak at ASAF annual meeting. A guest room, double occupancy, at the Playboy Club cost \$37.00 per person and included meals! The cost to print an issue of the Allegheny News in 1974 was 22 cents.

Lloyd passed away January 6, 2014 after a long and productive forestry career. With degrees in forestry and forest genetics from Southern Illinois University, Lloyd started his career with the Illinois Department of Conservation as a Service Forester and Nursery Specialist. He worked for the Department of Navy, managing woodlands on Naval bases before joining the USDA Forest Service, State and Private Forestry. Lloyd provided leadership for several landowner assistance programs and became a specialist in timber tax issues.

Lloyd is remembered for his no-nonsense tax presentations to landowner groups throughout the 20 States in Northeast and Midwest. He would often bring a crate to stand on, saying that "he was getting on his soapbox" to make important points. Even with this challenging subject, Lloyd could hold the audience's attention. He was always prepared with an engaging smile and many jokes. After retiring from the Forest Service, Lloyd developed a consulting firm where he was passionate about helping landowners manage their forests. He was a Certified Forester and Fellow in the Society of American Foresters; a past-President and Board Member for the Pennsylvania Forestry Association; and a Board Member and former Chairman of the Board for the National Woodland Owners Association.

In Memoriam

Hank DeBruin

Henry W. DeBruin, known as "Hank", 90, a 36-year resident of Arnold, Maryland, died peacefully in his sleep February 7. Born on May 27, 1923 in Grand Haven, Michigan to the late John and Ruth DeBruin, Hank lived the true American dream. He proudly joined the Navy at the age of 18 and served in WWII. Following the war, he went on to graduate from the University of Michigan with a degree in Forestry. In 1948, Hank went to work for the USDA Forest Service in Oregon with the desire to "ride a horse across the wilderness". Through many moves and promotions he served as a Forest Ranger and Forest Supervisor. As Director of Information and Education he was responsible for the Smokey Bear program. After 30 years of faithful service, he retired in Washington D.C., as Director of Fire Management and Aviation of the USDA Forest Service. Hank was elected Fellow in the Society of American Foresters in 1988 and presented with the Outstanding Service to Forestry Award by Allegheny SAF in 1991.

Hank was preceded in death first by his two daughters, Mary Martha and Dawn Ellen; his three sisters, Esther Miles, Virginia Whitman and Rosemary Austin; and two sons-in-law, Ronnie Bragg and Bob DeAngelis. He is survived by his beloved wife of 67-years, Martha DeBruin of Arnold; four children, Pat Bragg of Centreville, MD, Kathy (Bill) Bieckert of Newport News, VA, Dan (Kathryn) DeBruin of Victor, NY and Kim DeAngelis of Churchton, MD; 14 grandchildren and 28 great-grandchildren. Even though he never lost his love of the sea, the most important things in his life were his love of God and his family. This included extended family as well as the many others welcomed into his heart and his home. He left a legacy of faith and love and will be missed and remembered by everyone who knew him.

Stanley Walton



Stanley Arthur Walton, 84, passed away March 6, 2014 at Holy Spirit Hospital in Mechanicsburg, PA. Born in Pittsburgh in 1930, Stan later served in the US Navy during the Korean War. He went on to graduate from Penn State University and have a long and prosperous career with the Pennsylvania Bureau of Forestry. After retiring, Stan was very active in his community. He was an Elder in the Mechanicsburg Presbyterian Church, was active with the Mix-N-Mingles/Pepset and participated in the Carlisle Truck Stop Ministries.

Stan was a member of the Mechanicsburg Rotary Club, American Legion Post #109 and volunteered at the Ecumenical Food Pantry and Meals on Wheels.
